I/We acknowledge the above information to be true and correct and agree to the purchase of the ArmorCoat Limited Product Warranty for the term indicated above. I/We have read this Warranty in its entirety and fully understand its contents. I/We acknowledge receipt of a copy of this Agreement. I/We further understand that purchase of this Warranty is not required in order to purchase or obtain financing for this vehicle, and that my/our acceptance of the coverage under this certificate is strictly voluntary. Once the ArmorCoat Clear Bra product is applied to the vehicle indicated above, this Warranty cannot be cancelled.

Part IV: ArmorCoat Limited Product Warranty Benefits

Beginning on the date of product application and continuing for term selected above, this Warranty will cover paint chips or paint cracks caused by propelled rocks, stones or other road debris that come into contact with the covered vehicle's ArmorCoat Clear Bra while covered vehicle is being driven on public highways, streets or roads. Excludes fading of paint, color changes and any defect of the Clear Bra due to manufacturing or product failure. For complete terms and conditions of this Warranty, please refer to the reverse side of this document. If you have any questions regarding coverage, please contact NSD directly.

ArmorCoat Limited Product Warranty Terms and Conditions

This Warranty coverage is only available if the ArmorCoat Clear Bra application has been applied to the vehicle; additionally, this Warranty is only available through ArmorCoat and Nation Safe Drivers, as its Administrator. All customers must call our claims administrator, National Adjustment Bureau (NAB) at our dedicated toll-free number (888-684-9327) to obtain service.

NAB will not reimburse customers for services rendered outside of NAB's Network unless NAB gives authorization, in advance of any service.

ArmorCoat Limited Product Warranty: NAB will provide repairs to the covered vehicle up to a maximum of \$2,000 on automobiles, and up to a maximum of \$3,200 on recreational vehicles, over the term of this agreement. There is no coverage for any repair unless a NAB technician first determines that the damage meets the repair criteria. If damage is deemed to be repairable, NAB will contract for the repair of the damaged paint, and the restoration of the ArmorCoat Clear Bra to like new quality. NAB will contract with a qualified repair or replacement provider located within a reasonable proximity of the customer's need of service. NAB will provide a qualified repair or replacement provider located within reasonable proximity of the customer's need of service.

EXCLUSIONS

There is no coverage unless the ArmorCoat Clear Bra product has been applied to your covered vehicle. There is no coverage for any paint repairs when the metal below the paint is dented, punctured, or otherwise damaged in any way. There is no coverage for fading of paint, color changes, or any defect of the ArmorCoat Clear Bra product due to manufacturing defect or product failure other than as indicated in this Warranty Agreement. There is no coverage for damage that occurs on any unpaved roadway, or any roadway not regularly maintained. This Warranty is designed to only cover damage to paint protected by the ArmorCoat Clear Bra caused by stones, rocks or other flying road debris; therefore, there is no coverage for damage from collisions, vandalism, hail, or other weather related hazards, factory defects, any paint damage which occurs prior to the application of the ArmorCoat Clear Bra product, or any damage that is covered under your physical damage insurance. Other exclusions include: damage resulting from war, invasion, civil war, insurrection, rebellion or revolution, nuclear radiation or radioactive contamination, or any act of terrorism.

CANCELLATION AND TRANSFER

Cancellation: The paid purchase price for this Warranty is refundable within thirty (30) days **only if** the ArmorCoat Clear Bra product has not been applied. In order to receive a refund, you must send this Limited Warranty to the original dealership where this Warranty was purchased postmarked within thirty (30) days of Warranty purchase. The purchase price of the Warranty is nonrefundable after thirty (30) days of the delivery date or if the ArmorCoat Clear Bra product has been applied to the vehicle. All notices to cancel must be sent in writing to the original dealership AND Nation Safe Drivers. All cancellations will be calculated less a twenty-five dollar (\$25) fee.

Transfer: You may transfer this Limited Warranty to a subsequent owner of the covered vehicle for the remainder of the initial Warranty term provided that you comply with the following conditions: a) submit to Administrator at address below, a photocopy of this Agreement along with a money order for \$75 payable to Nation Safe Drivers within fifteen (15) days of vehicle resale; b) a letter requesting transfer to the new owner. Please include the new owner's name, address and phone number; c) your covered vehicle must be free of damage and Administrator reserves the right to inspect the covered vehicle before transfer is completed; d) this Limited Warranty may only be transferred by the original owner.

FOR CLAIMS YOU MUST CALL 888-684-9327

In the event of a claim, NAB must be notified immediately, and in no event more than thirty (30) days from date of loss. This is not a reimbursement plan, and in the event customer obtains service from a provider other than through, or authorized by, NAB, no reimbursement will be afforded and this Warranty will no longer be in effect.
